

1) Waiver & Release (Text Block)

WAIVER, RELEASE OF LIABILITY, AND ASSUMPTION OF RISK

I understand and agree that participation in a Chasing Tail event (“Event”) involves inherent risks, including but not limited to personal injury, illness, property damage, and risks related to animals, crowds, and outdoor/venue conditions. I voluntarily choose to participate in the Event with my dog(s) and assume all risks of any kind, whether known or unknown, foreseeable or unforeseeable.

To the fullest extent permitted by law, I, on behalf of myself, my heirs, assigns, and anyone claiming through me, hereby release, waive, discharge, and covenant not to sue Chasing Tail, its owners, officers, employees, contractors, volunteers, sponsors, vendors, exhibitors, venue owners/operators, and affiliated partners (collectively, the “Released Parties”) from any and all claims, demands, causes of action, damages, losses, liabilities, and expenses (including attorneys’ fees) arising out of or related to my participation and/or my dog(s)’ participation in the Event, including claims based on negligence, premises liability, or any other theory of liability, except to the extent prohibited by law.

I agree to indemnify, defend, and hold harmless the Released Parties from and against any claims, actions, damages, losses, liabilities, costs, and expenses (including reasonable attorneys’ fees) arising from or related to (a) my acts or omissions, (b) my dog(s)’ acts or omissions, or (c) my breach of these terms.

If I, or my dog(s), require medical or veterinary attention, I authorize the Event staff to obtain or assist in obtaining emergency medical/veterinary care, and I accept full financial responsibility for any resulting costs.

I understand that the Event may be recorded or photographed. I grant permission for Chasing Tail to use my name, likeness, and any photo/video/audio recordings from the Event for promotional and marketing purposes without compensation.

I certify that I am at least 18 years old and legally competent to agree to this waiver.
